Course Description

This course prepares students for jobs where decision makers must apply their business and finance training together with a keen understanding and appreciation for sustainability issues and goals. Examples for these jobs include:

- Finance roles in investment, asset management and private equity where ESG/CSR¹ and other sustainability related objectives/measures are fast becoming required knowledge.
- Equity analysis, risk management, and accounting roles, where understanding the ESG/CSR and sustainability risks and opportunities of firms is important.
- Advising roles for institutions facing pressures to divest from fossil fuels and other "sin" stocks in their endowments, pension funds, etc.
- Roles inside large and small non-financial corporations and not-for-profit institutions where financial literacy and finance skills are required in the pursuit of goals related to sustainability.
- Work in sustainability related non-profit or government agencies where a basic understanding in finance is helpful for "scaling up" any potential solutions by raising and deploying large amounts of financial capital.

This is a finance course, but it is not aimed specifically at students with mostly technical finance skills or highly technical finance career goals. We expect students in the course to have a wide range of proficiency in finance as well as pursuing diverse career goals. There will be a bit of math, but not too much. We do believe that all students will share a commitment to understanding sustainability issues. A background in sustainability is not required, but an interest is helpful. The course is a mix of cases and lectures, including discussions and guest speakers, and it involves a final hands-on group project.

Finally, this course attracts students across a wide spectrum of sustainability "beliefs": from those who want to dedicate their lives to sustainability objectives and changing to the world for the better, to those who work for fossil fuel or mining companies who seek to understand and consolidate and even expand the important roles of their firms in a modern world. We all learn the most by understanding all perspectives and appreciating each other's knowledge and energy – all in an environment of mutual respect.

¹ ESG scores: Environmental/Social/Governance ... these are more-or-less standardized metrics that are reported by firms and ratings agencies to summarize firms' exposure and activity in these areas. CSR: Corporate Social Responsibility.

Course Learning Outcomes

After completing this course, students will be able to:

- **Apply** financial tools and models to understanding and solving problems generally referred to as sustainability challenges (environment stresses, climate change, poverty, UN social development goals, income inequality, etc.).
- **Measure** and manage risks and opportunities associated with sustainability factors (ESG/CSR and other metrics) for investors, financial institutions and corporations.
- **Evaluate** the role of financial actors in generating sustainability problems and in solving these problems using financial markets and financial scale.
- **Understand** the role and impact of financial markets and instruments on sustainability related problems and solutions.
- **Discuss** sustainability from the perspective of a financial trained and sustainability-sensitive decision maker who faces audiences that may or may not be trained well in either finance or sustainability.
- **Critically examine** government policies and regulations and their impact on sustainability goals using the tools and models of financial economics.
- **Comment on** the opportunities and challenges faced by real companies (small and large) in the sustainability arena especially as it intersects with finance. This can include Social Entrepreneurship, Fintech solutions, and applications of Al/Blockchain.
- Appreciate various career opportunities in the sustainable finance sector.

Course Prerequisites

Contact Rotman Commerce Academic Services for academic advising if needed.

Pre-requisites are RSM332 and RSM333 (Capital Markets and Corporate Finance). If you want to take 332 and/or 333 as co-requisites, please talk to the Commerce Office. We will ask you to drop this course if you were to drop 332 or 333 during the term.

Course Materials

There are no textbook or electronic materials to purchase. Readings will be posted on Quercus.

Evaluation and Grades

Grades are a measure of the knowledge and skills developed by a student within individual courses. Each student will receive a grade on the basis of how well they have command of the course materials, skills and learning objectives of the course.

For situations in which students are not granted an academic accommodation from the Commerce Office or the Accessibility Services Office at Uoft for a missed or late deliverable, the missed or late deliverable will not be accepted. Expectations on Deliverables (Standard Rotman Commerce Language)

Writing Assignments and Presentations

The group project and the individual paper are – in part – intended to help you to continue to develop your communication skills. How well you communicate your ideas, in writing or orally, will be considered in the evaluation of the assignment <u>but it is a very minor component for the individual paper in this course</u>. In your written assignments, you should aim for clarity, strong organization, concision, professionalism, and correct grammar. Your presentations should reflect strong planning and organization, clarity of speech, and an engaging demeanour. Sources, whether in written or presentation assignments, should always be correctly attributed.

Support is available through the RC Centre for Professional Skills (CPS) for students who would like help or feedback on their writing or speaking (presentations). CPS offers both individual and group appointments with trained writing instructors and presentation coaches who are familiar with the RC program and common types of business assignments. You can also access your college Writing Centres for help with written assignments.

Group Assignments

The group project – not surprisingly – requires students to work in teams. Learning to work together in teams is a crucial transferrable skill you will use not only in your coursework, but also in your future careers. Support is available if you encounter common teamwork challenges such as:

- Team members feeling left out of the team.
- Team members not responding in a timely manner to communication.
- Division or quality of work among team members being unequal or unfair.

Teamwork mentors can help you resolve or mitigate conflict, strategize on planning, or improve team communication.

Class Participation

Class participation will occur in a safe, equitable, respectful, and kind classroom environment. This is nonnegotiable and students are encouraged to provide feedback and help the instructor improve the course in this dimension.

Student performance will be assessed based on the following criteria:

- Does the student help to advance class discussion (through questions or comments or answers)?
- Does the student participate actively during the in-class activities?
- Does the student know the case/reading facts and the business and/or sustainability issues raised?
- Can the student articulate focused, insightful, and relevant (non-repetitive) questions that bring the class forward in understanding a case or topic?
- Can the student respond to queries of the instructor and other students in ways that show thoughtfulness and some pre-class preparation of materials?
- Can the student distinguish the main, important ideas and refrain from simply listing a number of points without any good sense of which "matter" most?

The goal is to keep the conversation moving, to learn from each other, to challenge ideas, and to keep yourself and others focused and engaged and (yes) entertained.

Late or Missed Deliverables

Students who miss a test or assignment for reasons entirely beyond their control (e.g., illness) may request special consideration.

In such cases, students must:

- 1. Notify the instructor AND the Rotman Commerce Program Office **before or on the date** of the missed course deliverable. If you cannot reasonably contact them because of your special circumstance, you must contact them immediately when you are able. In all cases make sure you send an email so we have a system time-stamp of your communication.
- Complete a <u>Request for Special Consideration Form</u> and submit it along with your Absence Declaration on <u>ACORN</u> (please read the instructions on how to use the Absence Declaration in ACORN) within **2 business days** of the originally scheduled course deliverable.

Students who do not provide this information will be given a grade of 0 (zero) for the missed course deliverable. Once approved, students will be granted accommodation by extending deadlines until their time allotted for special consideration is over. For the final quiz, there will be a make-up date.

Class participation does not significantly suffer if a student misses one or two classes since the instructor only records "positive" contributions and does not punish for "negative" contributions or "absence". However, missing significantly more than two classes will likely put students in a position to be disadvantaged in accumulating positive contributions. If you miss more than two classes due to circumstances beyond your control, contact the instructor so we can work things out – documentation will be expected in most cases.

They may not be shared with others by these approved students.
