Course Scope and Mission

Price setting is probably the most crucial of all marketing mix decisions. It involves an understanding of both supply side factors (e.g. costs) and demand side factors (e.g. consumer willingness to pay). While traditional approaches to pricing theory have revolved around an economic and financial framework, a broader and more pragmatic view entails a comprehensive understanding of the demand side; both at the level of individual customer values, and the more aggregate level of price sensitivities of the market. In this course, we will approach the pricing decision as an intersection of economic, strategic, and behavioural considerations. Using product categories as diverse as healthcare, cell phone plans, consumer packaged goods and financial services, we will study economic and behavioural approaches to pricing, value pricing, price customization/discrimination, price bundling and multi-part tariffs, dynamic pricing, retail pricing strategies, pricing for goods/services with externalities, and pricing in two-sided markets.

Course Goals

After taking this course, you will be able to:

- 1) Understand the importance of the demand curve and customer willingness-to-pay in pricing strategy and learn methods of estimating the demand curve.
- 2) Learn how to calculate profit-maximizing prices.
- 3) Calculate expected value to customers (EVC) and develop the concept of value-based pricing
- 4) Understand the effect of non-price factors on price image and perceived value.
- 5) Understand innovative pricing strategies like peak period pricing, bundling, and price customization/discrimination.
- 6) Understand pricing for goods/services that generate externalities.
- 7) Understand how a two-sided market works, and the importance of pricing in two-sided markets.
- 8) Apply the concepts in a variety of business contexts.

Course Prerequisites

RSM250 Principles of Marketing is the prerequisite course. It is recommended that students be familiar with the material in introductory courses in economics and statistics.

Required Readings

There are two non-overlapped course packets: one hard-copy packet and one online packet. The hard-copy packet will be made available via the University of Toronto Bookstore. COURSE FORMAT AND EXPECTATIONS

There are three individual assignments and a group project presentation. The assignments consist of analytical problems and case analyses. The assignments are due on <u>Sep 26</u> (@6pm), <u>Oct 24</u> (@6pm) and <u>Nov 18</u> (@6pm). Group presentations are due on <u>Nov 20</u> @ 6pm (presentations will happen in class on Nov 21 and Nov 28). Late assignment and project submissions will not be accepted unless you have a valid reason stated under "Missed Assignments/Classes." with supporting proof/evidence, such as a doctor's note. Late assignment and project work submissions will incur a rolling penalty (e.g. 5 points deducted for each day's lag past the deadline).

In the first class, you will be asked to form a group of 4 students for the group assignments. Each group will work on the project presentation throughout the semester. The project will give you the opportunity to reflect on what you have learned in class and apply them to some practical problems of interest to you. If students do not form the group, they will be arbitrarily grouped. Also, in the instance that their team member drops the course – they will have to self-organize themselves into other groups. The Instructor or the TA will not own the responsibility to re-organize students into groups.

Re-marking: Requests to have assignments remarked will be considered if the following conditions are met:

- a) The student has debated his grading with TA first-hand and has valid counterarguments against the offered rationale;
- b) The assignment is submitted to the instructor no later than one week after the marked assignment has been returned to the student;
- c) the student submits with his/her request a written explanation as to why and where he/she believes he/she is entitled to more marks; and

d) the instructor has no reason to believe the student has made any changes subsequent to the assignment being returned.

If I accept your re-marking request, we will re-grade the entire assignment. Hence, the final grade of the assignment can either go up or down.

Class Participation

The purpose of this evaluation component is to give you practice in stating and defending your opinions orally. Credit will be given for all quality contributions that you make in class.

Since your participation is evaluated on its quality, not its quantity, think carefully about the contribution that your comments will make to the class. Airtime is limited, so don't talk just for the sake of talking. On the other hand, talking is not easy for some of you for a variety of reasons. This class is the time and place to develop the assertiveness and communication skills that are a prerequisite to success in business. To make things easier, in weeks where a case is assigned, *I recommend bringing your copy of the case analysis to class* for reference.

I need to know who you are to give you credit for your contributions, so be sure to keep your *name card* in front of you at all times. Your task is to judiciously enhance my memory for you as an intellectual and relevant contributor. Attendance and relevant participation is the key. Logistical clarifications and friendly banter does not count as participation. Missing class without notifying me will have a strong negative impact on your participation grade. All absence notifications should come at least 3 hours **before** class, **not** during class or after.

Final Exam

There is no final exam for this course.

To Use Turnitin.com:

Normally students will be required to submit their course essays to Turnitin.com for a review of textual similarity and detection of possible plagiarism. In doing so, students will allow their essays to be included as source documents in the Turnitin.com reference database, where they will be used solely for the purpose of detecting plagiarism. For Written Assignments:

Please note that <u>clear</u>, <u>concise</u>, <u>and correct writing</u> will be considered in the evaluation of all assignments and project work. That is, you may lose points for writing that impedes communication: poor organization, weak paragraph development, excessive wordiness, hard-to-follow sentence structure, spelling mistakes and grammatical errors. Students who require additional support and/or tutoring with respect to their writing skills are encouraged to visit the Academic Success Centre (<u>http://www.studentlife.utoronto.ca/asc</u>) or one of the College Writing Centres (<u>www.writing.utoronto.ca/writing-centres</u>). For Group Work:

The project presentation requires students to work in groups of **4**. Not 3 or 5.

Learning to work together in teams is an important aspect of your education and preparation for your future careers. That said, project-based teamwork is often new to students; to work well in teams, it helps to follow a set of core expectations to best succeed at your team projects.

1. Read the document entitled, "Working in Teams: Guidelines for Rotman Commerce Students" which is available on the RC portal under the Academic Services tab.

2. When working in a team, Rotman Commerce students are expected to:

- Treat other members with courtesy and respect;
- Honour the ground rules established by the team;
- Contribute substantially and proportionally to the final project;
- Ensure enough familiarity with the entire contents of the group project/assignment so as to be able to sign off on it as original work;
- Meet the project timeline as established by the team.

3. Resolving conflicts:

Conflicts are part of the team's process of learning how to work together. When handled well, it can generate creativity and bring-multiple perspectives to the solution.

Student teams are expected to work through their misunderstandings <u>as soon as they arise</u> (and prior to submission of the final project). When teams are unable to arrive at a solution that works for all members, the team must meet with the Rotman Commerce Team Coach** as soon as possible. The Coach will listen to the team and help develop options for improving the team process. All members of the project team must commit to, and, utilize their action plans.

POLICY AND PROCEDURE

Missed Tests and Assignments (including midterm examinations)

Students who miss a test or assignment for reasons entirely beyond their control (e.g. illness) may submit a request for special consideration. The Request for Special Consideration Form and supporting documentation must be submitted in a timely manner in order for the request to be reviewed.

In such cases, students must notify the Rotman Commerce Program Office <u>on the date</u> of the course deliverable such as a missed test, or assignment missed class (in the case of participation marks), or due date. They must then complete a <u>Request for Special Consideration</u> Form and submit it along with supporting documentation (e.g. <u>Verification of Student Illness or Injury form</u>) to the Rotman Commerce Office within **2 business days** of the originally scheduled course deliverable. Students who do not provide appropriate or sufficient supporting documentation will be given a grade of 0 (zero) for the missed course deliverable.

Documentation submitted in support of petitions for missing tests and assignments must be original; no faxed or scanned copies will be accepted.

Note that the physician's report must establish that the patient was examined and diagnosed at the time of illness, not after the fact. Rotman Commerce will not accept a statement that merely confirms a later report of illness made by the student to a physician.

In case of a make-up assignment needs to be offered because of medical absences, only 1 make-up opportunity will be offered and the submission timeline will be at the discretion of the instructor. It is likely to be between 1 and 3 calendar days. The grading criteria will be identical to the missed assignment, however, no late submission will be accepted on the make-up assignment.

There will be no make-up opportunity on the project work. In this case, the instructor will question other group members to determine how much effort was given towards project work by the student (who missed the project presentation), and accordingly determine the grade on the project work.

Late Assignments

Late assignments will incur a rolling penalty of 5 points for each day's lag past the deadline. Students who, for reasons beyond their control, are unable to submit an assignment by its deadline must obtain approval from the instructor for an extension. Supporting documentation will be required as per the policy on missed tests and assignments.
